2	<p>Minutes of Last Meeting (19.5.21) The minutes were accepted as a true and accurate record of the meeting.</p>	
3	<p>Matters' Arising All matters arising had been actioned or appeared as agenda items.</p>	
4	<p>Cabinet Member's Items - Councillor Richard Holt Unfortunately, Cllr Holt was unable to attend the meeting.</p>	
5	<p>Assistant Director's Items - Tim Browne <i>Reference 'SEND Progress Update and Future Improvement Plans' 17 June report to Full Cabinet; 'SEND Activity' document and 'Solihull SEND Update' powerpoint (copy attached to minutes)</i> TB talked through the Powerpoint presentation and made the following additional comments:</p> <ul style="list-style-type: none"> • Lisa Morris has been appointed Head of the Early Years' Service • Michele Sadler has been appointed Head of the Inclusion Service • Additional announcements will be made after the end of term and a briefing note will be circulated to schools prior to term starting in September. • The SEND framework is taking shape and improvements are starting to become evident. • The Service is committed to having a formal Joint Additional Needs Strategy in place in Autumn 2021. • TB thanked Charlotte Jones and Amanda Hana for driving the improvements forward. • TB expressed concern about Solihull's lack of specialist provision capacity and how we deal with the additional pressure this will bring. The Specialist Commissioning Strategy is being developed. • The DfE SEND Review is likely to put additional pressure on LAs and schools. This is expected to be delayed further. • The SEND service is now six months into its five-year improvement journey and a lot of ground has been covered during that time. <p>TB invited questions and comments:</p> <ul style="list-style-type: none"> ➤ AF felt that an enormous amount of work had been done very quickly, but asked members to reflect on how it feels in schools and settings. ➤ GG – it has been an exceedingly difficult year for her nursery and its parents, mainly due to lack of communication and listening, particularly when there has been a need for specialist provision. This has caused families to become very upset and unsure where to turn. It is imperative to get the communication right if we want to improve parental confidence. ➤ TB – a number of factors have caused difficulties - turnover and insufficiency of staff, insufficient specialist places and a 25% increase in EHCP requests between February and May. However, the right framework is now in place and this, together with a quality and stable workforce, should make a difference, but TB appreciated GG's comments. ➤ DG – north Solihull schools had hoped we would be further forward by now as regards relationships and people to call on; he agreed with GG and felt that young people were being 'passed around a bit'. DG felt that, despite changes at strategic level, which he fully supported, assurances were needed that the operational side would be quickly embedded so that schools can see positive action and outcomes. ➤ TB – agreed the importance of ensuring strategic changes translate to the front line, at a time of increasing demand. However, pushing forward is reliant on a stable workforce and the service is struggling to fill posts quickly enough (SMBC is looking at ways to respond to this through its Workforce Strategy). It is anticipated the new posts will be filled by September. ➤ JG – the same difficulties are being experienced in south Solihull for the same reasons. Whilst appreciating TB's comments, JG felt it vital that we acknowledge and stress the difficulties on all sides; it is extremely challenging for schools and getting worse and a lot of families are bearing the brunt of this. There is a lot to be pleased about moving forward, but as yet it is difficult to see the impact of service improvements. ➤ JD (via chat) –these are equally challenging times for special schools. 	<p>attached</p> <p>NOTE</p>

	<ul style="list-style-type: none"> ➤ AF – it is vital to continue getting the message out to all stakeholders that the LA is putting significant improvements in place, although the impact may not be immediately evident. ➤ RF – raised a number of points. Despite the range of improvements, the LA has not acknowledged that schools and leaders have not yet seen any impact. He raised concern at the push for mainstream schools to be more inclusive, but has not heard yet how schools would be supported to do this. He sought assurance that the AP Strategy would come to fruition. ➤ TB – gave assurance that Solihull’s previous lack of a coherent AP offer would be rectified; plans for sixth day provision through Solihull Academy are taking shape and an AP Strategy will be drawn up, including consultation with schools in Autumn term.
