I have now retired from full time employment, but my career spanned 37 years in children's services in a number of roles, starting as a social worker and then in management positions at various levels. Over the last 15 years or so I worked at senior level and closely with partners on the safeguarding agenda, largely in authorities on significant improvement journeys. My last post was in Wakefield as the Director of Children's Services, where I led the team which turned round an inadequate rated children's service to become rated good by Ofsted with outstanding leadership within just over 3 years.

Learning from Multi-Agency Audits

Throughout Q1 23/24 the SSCP Audit Group completed an audit on the theme of Neglect. The audit identified some good practice as well as areas for multi-agency learning. Neglect

Background:

In June 2023, a deep dive audit was undertaken to look at the multi-agency response to 7 children for whom there were concerns of neglect. This included looking at 2 children who were in receipt of early help, 2 children who had Child in Need Plans and 3 children who had Child Protection Plans.

Good Practice

- For the most part, referrals were of a good quality
- Strategy meetings have been undertaken where necessary
- The voice of the child was captured for a number of the children we looked at
- Good multi-agency input in assessments
- All reviews took place within timescales
- Good multi-agency contribution to review the plan

The audit findings remind us to:

Information sharing – ensure information is shared at the earliest opportunity around neglect concerns, particularly with agencies who have regular contact with the child such as Education

Chronologies (timeline of involvement) – ensure timelines of involvement are routinely kept up to date. Any new information should always be included to help practitioners to identify patterns of risk, harm, and protective factors and how they have occurred over time. They also help plan next steps for assessment and intervention.

Impact of neglect – give more consideration to understanding the short- and long-term impact of all forms of neglect in relation to a child's needs for example, self-esteem and forming relationships. Understanding the impact of neglect on a child and family is imperative to ensure interventions are effective.

A guide to Multi-Agency Meetings relating to Safeguarding Children and Young People



"Everyone who works with children has a responsibility for keeping them safe. No single practitioner can have a full picture of a child's needs and circumstances and, if children and families are to receive the right help at the right time, everyone who comes into contact with them has a role to play in identifying concern, sharing information, and taking prompt action." – Working Together 2018

The purpose of the meeting	Preparing for the meeting	Participation at the meeting	Multi-Agency Plans	After the meeting
Share key knowledge and information regarding the child and/or their circumstances, environment (parents) or carer(s) harm outside the home. Produce a plan to reduce the worries and concerns for the child/young person and family. Be transparent	Ensure relevant agencies are invited to attend Clarify the voice of the child to ensure the meeting is focused around them Be aware of the type of meeting you are attending – know what multi-agency procedures you are following Familiarise yourself with information your agency hold on the child/young person, their parents/carers, and their circumstances	Listen to opinions, even if you don't agree with them – you have a right to challenge in a respectful way Focus on outcomes Be accountable and take responsibility for your role in safeguarding children and young people Consider the information shared by others, not just from your own agency A parent/ carer should not be hearing something about their child for the first time in a multi-agency meeting	Draw up a clear plan of action with timescales and who is responsible, with SMART actions and contingency plans if change is not sustained In the event that there is disagreement between agencies, consider how this might be resolved, possibly outside the meeting or using the Classic Resolution Procedures	Take responsibility for chasing for a summary of the meeting or plan if this has not been received in a timely way Ensure any actions for your agency are completed within the agreed timescales It is everyone's responsibility to raise concerns if the plan is not working

Local Child Safeguarding Practice Review – Baby JS

In September, the SSCP published a Local Child Safeguarding Practice Review (LCSPR), known as JS. This is a sad case of the death of a 4-month-old baby and for those that attended the CSPR learning event in May, you will already be familiar with some of the details. <p>1. What is 'Coercive Control'?</p> <p>Coercive control is a term used to describe a pattern of behaviour that takes place over time. It covers a range of behaviours that a perpetrator uses to isolate, control and make their victim feel inferior, dependent and frightened.</p> <p>Coercive control is a key factor in domestic abuse, child and adult safeguarding, exploitation and modern day slavery.</p>	<p>1. What is 'Complex Needs'?</p> <p>Everyone is unique and shaped by their experiences.</p> <p>People have a variety of needs and it's the interaction of these unique needs that leads to complexity.</p>	<p>1. What is meant by 'Cross Boundary Issues'?</p> <p>A border is a dividing line, marking the boundary of an area. Our differences or contrasting organisations will have geographical (and/or service) boundaries. It's not always clear where our responsibility is, but it's not enough. It's unclear what happens when we fall at regional boundaries.</p> <p>Many people don't care about the legal boundaries they cross when they do daily activities, but we aware when they cross the boundary of a country, as this often requires them to produce their passport to get on with it.</p> <p>Solihull is a Metropolitan Borough Council area of the West Midlands, situated in the middle of one of the region's major city conurbations, Birmingham & Coventry. It is also bordered by Staffordshire.</p>

CAFCASS New Website

For every child whose current & future living arrangements are decided by the family court, Cafcass has the role of advising the family courts about the welfare of children and what is in their best interest. Through September - December 2023 we will not have access to a ground floor space to deliver safeguarding training and the space we have is only available via stairs, there is no lift.

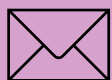
