#### **SSCP LOCALITY BASED TRAINING**

Solihull Safeguarding Children Partnership are pleased to offer locality-based training to encourage those working/ volunteering near to the new family hub or outreach sites to come together to learn.

This training session will focus on **Safeguarding Babies Under 2**. People who wish to attend are encouraged to attend in a locality that they are based, work or volunteer directly with people in that area.

Locality based training is being offered around Solihull to bring those working/ volunteering in an area together. Our focus at the next session is safeguarding babies under 2 looking at three main components - Safe Sleep, Safe Handling and Safe Space. Following learning from multi-agency audits, as a Partnership, we have produced guidance which we hope will be useful for everyone who receives or delivers supervision. This guidance is not intended to replace any agencies standards for supervision but instead provides information on the different types of supervision, multi-agency professionals' meetings and escalations. ### Are you aware of the SSCP Escalation Procedure?



When a range of professionals and agencies are undertaking assessments and providing services for people, there will inevitably be times when perspectives differ, and conflicts of opinion or views give rise to challenge. Challenge can take place between partner agencies and is not always just about partner agencies challenging the Local Authority Children's Services. If professional challenge

and discussions have failed to reach a decision then the SSCP Escalation Procedure should be followed. This can be found here.
