Purpose of the Group

- To strengthen partnership working with providers.
- To gather “word on the street” intelligence on local authority decisions and their impact.
- To act as a feedback and reference group

Key Agreements

- **Meetings** will continue **virtually**, with the option to review face-to-face meetings in future.
- **Membership term** agreed at **two years**, with refresh/re-advertising around **January 2028** to allow wider provider participation.

Early Years Funding Update (Stephen Fenton)

- National funding rates were released **15 December**, with short statutory timescales.
- Solihull funding remains **low compared to some of our neighbouring authorities** (e.g. Birmingham). Rate for Solihull providers is reflective of the amount the local authority receives (less than other LAs).

- Local funding rates already shared with providers; changes are **unlikely** pending formal ratification in February.
- Funding formula principles reiterated:
 - Maximise the **basic hourly rate**.
 - Maintain **stability and consistency** for providers.
 - Limit supplements (only deprivation and historic teacher pension supplement).
 - Ensure transparency – all funding is fully accounted for.
- Movement of unused SEN Inclusion Fund (SENI) monies into the basic rate where not being spent.
- Move toward **termly census (13/14/11 weeks)** to better align with DfE funding and reduce volatility.
- Commitment to explore **tweaks and longer-term options**, including SEN funding for children with EHCPs.

Funding Clarifications

- Published hourly rates explained (including confusion caused by dual national rates).
- Local authority rate for 3- and 4-year-olds reflects allocation after central spend and supplements.
- Providers encouraged to raise follow-up questions after reflecting on information.
- LM shared the fact that she was working to use unclaimed DAF monies to support SEND in Solihull settings

Compliance and Charging Transparency (Rosie Ratcliffe)

- New statutory guidance requires **clear, transparent information** for parents on:
 - Funded hours
 - Charges (meals, consumables, extras)
 - Opt-out options
- Majority of providers now compliant; some settings, schools and childminders still being followed up.

- Artificial breaks within funded sessions are **not compliant** and have been addressed.
- Two publication options supported:
 - Provider's own website
 - Local authority template linked via Family Information Directory
- Ongoing dialogue with DfE regarding how explicit settings must be about offering "funded-only" places.
- LA approach remains **supportive, not punitive**, with case-by-case resolution where issues arise.

Childcare Sufficiency Assessment (Ann Pearson)

- Annual statutory duty to assess childcare sufficiency (supply vs demand).
- Provider data is critical and more valuable if response rates improve.
- Proposal supported to:
 - Add **short supplementary questions** alongside the **termly headcount census**, rather than one large standalone survey.
 - Possibly vary questions by term (e.g. places, vacancies, waiting lists).
- Aim to make data collection easier and more useful for providers' **business planning**.
- Feedback will be shared with providers to demonstrate how their data is used.
