Provider Survey Results Autumn 2023

Thank you to everyone who took the time to complete our recent survey. We wanted to find out what capacity you have and if you have any plans to increase your provision

The survey was sent out to 235 childcare providers and Schools

We have received 64 responses

20 providers have children under 2 years old on a waiting list

13 providers have children aged 2 years on a waiting list

15 providers have spaces for under 2's

23 providers have spaces for 2 year olds

5 providers would consider expanding their provision next year

The most common reasons for not expanding are to do with lack of space and the cost of employing more staff

16 providers have space to expand if demand increased

We may send out further surveys to establish local supply and demand. Your feedback is valuable and appreciated



Finance matters...

- "29th November 00:01), we (the DfE) will announce the local authority hourly funding rates for 2024-25 and publish the government's response to the recent consultation on early years entitlement funding...
- · What we have to do:
- construct a local funding formula agreed we will do this based on the same principles and proportions as the 3 – 4-year-old formula – a basic unit rate and a supplement for deprivation.
- Establishes inclusion funding for 2 year-olds and under 2s (funded from the local authority received rates for 2 and under 2 early years grant funding)
- construct plan for additional staffing to deliver the proposals, based on retaining up to 5% of the additional grant to be received, as permitted by the government (agreed by School Forum).
- BUT at the moment don't have necessary info to do any of this

Finance matters...

- Providers have told us they must have indication of rates for their Business planning in January
- May need to model estimated rates, then, if necessary, re-adjust in-year
- All we know at the moment:
- Provisional 2 YO rate £7.87 (paid to LA, but also needs to pay for a
 deprivation supplement and 2 YO Inclusion fund, and additional central
 services, so basic rate to providers will be less than this) Currently £7.75
- Provisional U2 Rate £10.70 (again this will reduce as a base per hour rate as have to have a deprivation supplement and an inclusion fund element, and central services)
- Early years pupil premium hourly funding rate £0.68 (£0.66 currently)
- Disability access fund yearly funding rate £902 (£881 currently)



Government Entitlements

- From April 2024, working parents of two-year-olds will be able to access up to 15 hours of early education funding per week from the term after their child's 2nd birthday;
- From September 2024, this will be extended to working parents of children aged 9
 months and above;
- From September 2025, working parents will be able to access up to 30 free hours per week for children from age 9 months up until 1 September following his or her fifth birthday.

A child will be entitled to the additional funded hours from the term after both of the following conditions are satisfied:

- 1) the child has attained the relevant age;
- 2) the child's parent has a valid eligibility code from HMRC.



- For 2 year old funding there will be 2 schemes the existing benefits related criteria (including LAC children and children in receipt of DLA) and working families. Where families meet both criteria we will be asking parents to apply via the existing criteria (to Solihull Council) as parents won't need to re-confirm codes every 3 months.
- Working parents will apply to HMRC as they do for 3&4 year old extended hours.
- Parents on benefits will continue to apply via to FIS via the Parent Portal.
- Please direct parents to the correct application procedure. We will be directing
 parents who don't meet the benefits check to HMRC but it would be helpful if you
 can explain the correct process to parents to speed things up.
- Working parents of children who are age eligible for 2 year old funding from April 2024 can start applying for their 2 year old funding eligibility code from 2nd January 2024.
- Childcare providers should follow the existing 30 hours process of checking the
 eligibility code before offering a place using the eligibility checker on the provider
 portal and gathering the information via the Parental Declaration Form.



- Parents will be expected to re-confirm their code every 3 months (reminder will be sent from HMRC).
- FIS will **audit codes 5 times per year** and ask you to let the parents know if they haven't completed their reconfirmation.
- It is proposed that **EYPP, DAF and Inclusion Fund** will be extended to the younger age groups. The result of this consultation will be in early 2024.
- New Statutory Guidance on Early Years and Childcare will be issued in January 2024. We will distribute when it arrives and highlight any changes made by the DFF



Monthly Payments

- Pilot scheme in Summer 2024 term.
- Full rollout from Autumn 2024 term. You will be asked if you want to sign up to this option in Summer 2024 and if you sign up this will be your funding method for the academic year.
- The default payment method will be the 75% advance payment, 25% headcount payment. You will need to sign up to monthly payments during Summer 2024 term when prompted. We are unable to switch payment method during the academic year due to the impact on other Council teams who assist with processing the payments.



FIS Provider Helpline

- We are proposing that there will be 1 helpline telephone number and email
 address for you to contact regarding funding queries rather than you contacting
 different colleagues in the FIS team.
- All staff who answer the helpline will be trained to deal with your enquiry. This will help streamline customer service and ensure you get an answer as quickly as possible.

The principal aim of the programme is to ensure childcare provision is regular, has longer hours and is more dependable for working parents

Lisa Morris- shared at HT breakfast meeting



- The government's ambition is that by 2026, all parents and carers of primary school-aged children who need it will be able to access term time childcare in their local area. This should be available from 8am-6pm, so that parents can access employment and improve labour market participation.
- The expectation is that all wraparound provision is 8am-6pm, enabling parents to work a full day with travel time, unless data shows that local demand is for different hours, for example reflecting local labour market patterns.
- Whilst schools are integral to this programme, not all schools will provide wraparound childcare directly



Definition WA - wrap around

- Primary schools YR to Y6
- REGULAR before and after school care [not one-off clubs] Monday to Friday
- · 8am to 6pm at least
- This provision can be offered by schools and private, voluntary and independent (PVI) providers (including childminders and early years settings) and can be run on a school site or at another setting in the area.



- It should not require parents to pick their children up from school and drop them off at another location.
- The programme should deliver provision that is child-centred, easily accessible, and responds to the needs of the families, including those of children with special educational needs and disabilities (SEND).
- · LAs will get some capacity and capital funding
- Develop and expand provision for every schoolbuilding on strong partnerships already in place [such as Beechwood Childcare on 5 Solihull school sites]



 DfE plans to publish guidance for schools + in early 2024, which will include practical guidance to support those who wish to deliver or expand wraparound childcare provision


